# GOVERNING BOARD MINUTES REGULAR MEETING with EXECUTIVE SESSION TUESDAY, APRIL 11, 2023

### 1. Call to Order and Roll Call

The Tolleson Union High School District No. 214 Governing Board regular meeting was called to order at 6:00 p.m. by Governing Board President, Dr. Elda Luna-Najera, with the following members in attendance: Mr. Steven Chapman, Mr. Devin Del Palacio, and Mr. Freddie Villalon, Members. Dr. Kino Flores, Vice President, was absent.

### 5. SUMMARY OF CURRENT EVENTS

### **Superintendent Gutierrez Comments**

- Westview FCCLA has a total of nine students going to Nationals. Westview had seven Gold First Place students and 20 second place Silver students. Students earned awards in such categories as Interpersonal Communication; Fashion Design; and Entrepreneurship.
- Congratulations to Copper Canyon's FBLA Media chapter for earning a Gold Chapter Award from the Arizona Future Business Leaders of America organization at the CTSO's State Conference in Tucson on April 4. Aztec Media was the only TUHSD Chapter, and one of only 10 high schools statewide, to achieve gold-level status for the 2022-23 school year. Copper Canyon FBLA Media was a bronze chapter last year at their first state conference as an FBLA chapter. The student officers made it a goal this year to go for the gold at the start of the year. Great job!
- We are proud to announce that TUHSD has a total of 350 students that were accepted to West-MEC for the 2023-24 school year. Copper Canyon has 68; La Joya has 60; Sierra Linda has 35; Tolleson Union has 45; University High School has 28; West Point has 70; and Lighthouse Academy has 1. Congratulations to all of these students.
- Ms. Katherine Phillips, who teaches English at Copper Canyon High School, got quite a surprise
  from Sun-Tec Concrete last Thursday. She was nominated by a student at Copper to receive
  school supplies for her classroom. Sun-Tec provided approximately \$2,000 in class supplies.
