REGULAR MEETING

It was recommended that the Governing Board adopt a statement of charges for dismissal of Scott Joseph Tafoya Sanchez, an administrator at WHS, and dismiss Mr. Tafoya Sanchez effective 10 days from the date of receipt of statement of charges subject to Mr. Tafoya Sanchez's right to a hearing, and place Mr. Tafoya Sanchez's on administrative leave.
