Students had an opportunity to hear the two drivers, both African American, talk about their experiences in becoming NASCAR drivers on the circuit. In addition, Larry Fitzgerald, formerly of the Arizona Cardinals, joined the Q & A session to talk about his experience in overcoming obstacles growing up as a kid. Students also had an opportunity to drive race cars via an XBOX simulator in the community room next to the PAC.
